CERTIFICATE

In response to the petition dated 22 July 2024, as amended, filed by „AMS METAL” Sp. z o.o. (NIP [taxpayer's ID]: 9542184449) with its registered office at ul. Chemiczna 5 in Siemianowice Śląskie, for release of the certificate pursuant to the art. 217§ 1 and 2 and art. 218 § 1 of the act dated 14 June 1960 Administrative Procedure Code (uniform text: Journal of Laws of 2024, item 572, as amended);

it is hereby declared that:

AMS METAL Sp. z o.o. (NIP [taxpayer's ID]: 9542184449) with its registered office at ul. Chemiczna 5 in Siemianowice Śląskie has provided the local authority with a new petition dated 21 February 2023 for issuance of the authorisation to generate waste with special regard to waste processing and collection conditions (the petition was submitted to the General Administrative Centre of the Marshal's Office on 24 February 2023).

Pursuant to the art. 226a of the act dated 14 December 2012 on waste and art. 193 para. 1C of the act dated 27 April 2001 Environmental protection law:

„until 31 December 2025 the authorisation referred to in the art. 180a shall not expire if the waste holder files a petition for release of a new waste generation authorisation within three months before the authorisation deadline at the latest.

Bearing the above in mind, the decision taken by the Mayor of Siemianowice Śląskie as of 27 May 2013, mark: IR-OS.6233.28.2013 (effective until 26 May 2023), altered through the decision of the Mayor of Siemianowice Śląskie as of 15 November 2016, mark: RS.6233.0048.2016 and decision taken by the Mayor of Siemianowice Śląskie as of 20 April 2018, mark: RS.6233.0060.2017, **meets the requirement stipulated in the aforementioned articles and, upon issuance of this certificate, the decision in question remains binding and in legal circulation.**

According to the provisions of the aforesaid art. 193 para. 1C and 1d of the act dated 27 April 2001 Environmental protection law, the previous authorisation referred to in art. 180a, expires on the day that follows the day on which:

- 1) new authorisation, decision to refuse to issue a new authorisation or decision to dismiss proceedings on issuance of a new permission have become final, or
- 2) the petition for issuance of a new authorisation has not been considered by a relevant authority

Upon issuance of this certificate, the Marshal of the Silesian Province has neither taken a decision to dismiss the proceedings nor failed to consider the new petition.

Also, please be informed that the proceeding on the change of the decision as of 27 May 2013, mark: IR-OS.6233.28.2013 pursuant to the art. 13 of the act dated 20 July 2018 on the change of the waste act and some other acts (Journal of Laws of 2018, item 1592) has not been completed as of the response day.
